

BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the OFFICE OF THE PROVINCIAL SOCIAL AND WELFARE AND DEVELOPMENT of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2020-C-038 re: PROVISION OF MEALS & SNACKS FOR THE INTERNATIONAL SOCIAL WORK DAY with an ABC of ₱ 105, 000.00;
