
WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that DBP CONSTRUCTION CORP. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals;


WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, DBP CONSTRUCTION CORP. has been found to be ELIGIBLE and its bid, RESPONSIVE;


