**WHEREAS**, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 19-0841 series of 2019 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the BOHOL DISTRICT JAIL in undertaking Procurement Request under PR No. 2019-0294 re: CONSTRUCTION OF ISOLATION CELL AT BOHOL DISTRICT JAIL, TAGBILARAN CITY with an ABC of ₱ 699,396.73;



**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVES**, as it is hereby **RESOLVED**:




