WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 20-0098 series of 2019 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE PROVINCIAL VETERINARIAN in undertaking Procurement Request under PR No. 2019-0701 re: Procurement of Various Janitorial Supplies at the Office of the Provincial Veterinarian, New Capitol Compound, Tagbilaran City.. with an ABC of ₱ 65,534.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that GOLDEN AI TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;
