

BAC Resolution Declaring SCRQ through Negotiated Mode of Procurement – Emergency Cases and Recommending Award

WHEREAS, the PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2020-C-074 re: PROVISION OF MEALS FOR THE SUPPORT PERSONNEL MANNING COVID 19 QUARANTINE FACILITY AT NATIONAL IRRIGATION AUTHORITY (NIA), UBAY with an ABC of ₱ 168, 000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement – Emergency Cases showed that PANDA TEA GARDEN SUITES offered the single price quotation as reflected in the Abstract of Bids Proposals;

- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.




