

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contracts. As such, the entity covenants to pay the supplier every end of the month of the **Janitorial Services** being rendered subject to the usual auditing rules and regulations;

4. The Entity hereby covenants to pay the Supplier in consideration of the provisions of the goods and services and the remedying of defects therein, the Contract price of such other sum as may become payable under the provision of the Contract at the time and in the manner prescribed by the contract.

5. The Entity also admits that services were already provided even though the contract was not yet finalized considering the necessity of the services requested. This was materially discussed in the attached letter, marked as Annex A, wherein an earnest request for the continuity of the **Janitorial Services** are explicitly pointed out to be indispensable and urgently needed. Thus, the Entity also covenants to pay the Supplier for the services rendered prior to the preparation of this agreement.
