

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the CONG. NATALIO P. CASTILLO SR. MEMORIAL HOSPITAL, LOON, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2020 - 025 re: PROCUREMENT OF DENGUE COMBO TEST with an ABC of P 310,000.00;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:



- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings


