

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

RESOLUTION NO. 70 -0042 Series of 2020

WHEREAS, the <u>PROVINCIAL MOTOR POOL OFFICE</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2019-0741</u> re; <u>Procurement of Starter Motor Assy.</u>, <u>Hydraulic Hose Assy.</u>, <u>Empty Drum & Engine Oil Filters for use at Provincial Motor Pool Office</u>, <u>Tagbilaran City</u>, with an ABC of <u>P 90,730.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>CARE AUTOHAUS</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
