



**BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval**

**WHEREAS**, the **CONG. NATALIO P. CASTILLO SR. MEMORIAL HOSPITAL, LOON, BOHOL**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. - PHO - 2019 - 288 re: **PROCUREMENT OF 9V BATTERIES, BED MATTRESS & VARIOUS JANITORIAL SUPPLIES** with an ABC of **P75,700.00**;

**WHEREAS**, canvass of prices done in the course of the Negotiated Method of Procurement showed that **3 MSG ENTERPRISES** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,
