



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the CONG. NATALIO P. CASTILLO SR. MEMORIAL HOSPITAL, LOON, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2019 - 288 re: PROCUREMENT OF 9V BATTERIES, BED MATTRESS & VARIOUS JANITORIAL SUPPLIES with an ABC of P75,700.00;
