WHEREAS, the CENTER FOR CULTURE AND ARTS DEVELOPMENT of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2020-C-055 re: PROVISION OF MEALS AND SNACKS DURING THE PREPARATION OF THE SANDUGO FESTIVAL 2020 with an ABC of ₱ 142, 500.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that CASA REY FRANCIS PENSION HOUSE AND RESTAURANT offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
