WHEREAS, the **OFFICE OF THE GOVERNOR** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2019-0831, Procurement of Amakan, Native Decorative, Bamboo Slat, Rattan, Nipa, Hardware & Construction Materials for the Fabrication of Tables & Tents Accessories for the use During the Christmas & Fusion Nights at CPG Park, by the Office of the Governor, New Capitol Compound, Tagbilaran City. with an ABC of P 260,437.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **D 18TH HI-WAY MARKETING** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
