WHEREAS, the OFFICE OF THE GOVERNOR of the PFOVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2019-0831, Procurement of Amakan, Native Decorative, Bamboo Slat, Rattan, Nipa, Hardware & Construction Materials for the Fabrication of Tables & Tents Accessories for the use During the Christmas & Fusion Nights at CPG Park, by the Office of the Governor, New Capitol Compound, Tagbilaran City. with an ABC of P 260,437.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>D 18TH HI-WAY</u> <u>MARKETING</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
