WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 19-0978 series of 2019 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **GOVERNOR'S OFFICE** in undertaking Procurement Request under PR No. 2019-0817 re: Procurement of Vehicle Repair with Spare Parts & Engine Oil for the Service Vehicle Assigned at Office of the Governor, New Capitol Compound, Tagbilaran City. with an ABC of ₱ 155,910.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **TAGBILARAN CITY TYRE SALES AND SERVICE CENTER** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:




