

BAC Resolution Recommending Procurement thru Negotiated Method Resulting from the Second Failure of Bidding, Declaring LCRQ and Recommending Award

RESOLUTION NO. 10-2007 Series of 2020

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 19-0978 series of 2019 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the GOVERNOR'S OFFICE in undertaking Procurement Request under PR No. 2019-0817 re: Procurement of Vehicle Repair with Spare Parts & Engine Oil for the Service Vehicle Assigned at Office of the Governor, New Capitol Compound, Tagbilaran City. with an ABC of **£ 155,910.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that TAGBILAR CITY TYRE SALES AND SERVICE CENTER offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, TAGBILARANCITY TYRE SALES AND SERVICE CENTER has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:
