WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST - NUTRITION of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2020-C-037 re: PROCUREMENT OF MEALS AND SNACKS FOR THE BARANGAY NUTRITION SCHOLAR'S MEETING AND BARANGAY NUTRITION SCHOLAR'S SUMMIT with an ABC of ₱ 598, 500.00;
