

WHEREAS, the BOHOL EMPLOYMENT AND PLACEMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2020-C-066 re: PROVISION OF MEALS & SNACKS DURING THE GIP FACILITATION with an ABC of **P92,000.00**;
