WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 19-0 series of 2019 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **GOVERNOR'S OFFICE** in undertaking Procurement Request under PR No. 2019-0816 re: Procurement of Various Vehicle Spare Parts, Engine Oil with Labor for the Service Vehicle Assigned under the Office of the Governor, New Capitol Compound, Tagbilaran City, with an ABC of ₱ 381,130.00;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:






