



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the OFFICE OF THE PROVINCIAL SOCIAL WELFARE & DEVELOPMENT of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2019-0938; Procurement of Well Milled Rice, by the Office of the Provincial Social Welfare & Development, New Capitol Compound, Tagbilaran City. with an ABC of P 100,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that LEBAK SUSTAINABLE ORGANIC AGRICULTURE MULTI-PURPOSE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
