



**BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval**

WHEREAS, the **PROVINCIAL MOTOR POOL OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. **2019-0837**; re: **Procurement of Acetate, Industrial Oxygen & Various Vehicle Spare Parts for the Automotive Repair Maintenance Division at the Provincial Motor Pool Office, Tagbilaran City**, with an ABC of **P 108,072.50**;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **CARE AUTOHAUS** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **CARE AUTOHAUS** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **CARE AUTOHAUS** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:

- a.) To declare **CARE AUTOHAUS** as the bidder with the **LOWEST CALCULATED AND RESPONSIVE BID** for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. **19-0445**;
- b.) To recommend award to **CARE AUTOHAUS** for the delivery of goods/services under Negotiated Canvass No. **19-0445** in the amount of **P 108,033.50**;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
