THIS AGREEMENT made between the **Provincial Government of Bohol**, Capitol Compound, Tagbilaran City (hereinafter called "the Entity") of the one part and **DEPENDABLE SECURITY AGENCY**, # 17 Tabaco Street, Cogon District, Tagbilaran City (hereinafter called "the Supplier") of the other part.
