

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the GOVERNOR'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2019-0036; re; Procurement of Tablet Smart Keyboard Folio Lightning Digital AV Adapter & Magic Mouse, by the Office of the Governor, New Capitol Compound, Tagbilaran City. with an ABC of P 139,995.00:
