



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the GOVERNOR'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2019-0036; re: Procurement of Tablet, Smart Keyboard Folio, Lightning Digital AV Adapter & Magic Mouse, by the Office of the Governor, New Capitol Compound, Tagbilaran City. with an ABC of P 139,995.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that GOLDEN AI TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
