



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the GOVERNOR'S OFFICE – SPECIAL PROJECT SECTION, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2019-0707; re; Procurement of Transport Rental for Visiting Dignitaries (Foreign & Local VIPs) During Special Events, Surgical Missions & Hosting for the 4<sup>th</sup> Quarter 2019 for use by the Governor's Office – Special Project Section, New Capitol Compound, Tagbilaran City. with an ABC of P 65,000.00;
