



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **OFFICE OF THE PROVINCIAL VETERINARIAN** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. **2020-0053**; re; **Procurement of Power Sprayer to be used in Spraying Disinfectant for African Swine Fever Prevention & Control, by the Office of the Provincial Veterinarian, Tagbilaran City**, with an ABC of **P 170,000.00**

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **OCCIDENTAL ENTERPRISES** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;






