

WHEREAS, upon the conduct of post qualification by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC., PANDA TEA GARDEN SUITES and JJ'S FOODLAND CORP. bidders were declared as the **LOWEST CALCULATED BID PER ITEM**, successfully passed the Post Qualification process, thus the committee now considered its bid as the **LOWEST COMPLYING** and **RESPONSIVE BID** for the said project while CASA REY FRANCIS PENSION HOUSE AND RESTAURANT failed to Pass the Post Qualification process (see page no. 1 of Post Qualification);

WHEREAS, upon recommendation by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by PANDA TEA GARDEN SUITES, JJ'S FOODLAND CORP. and REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC. the bidder declared as the **LOWEST CALCULATED BID**, successfully passed the Post Qualification process, thus the Committee now considered its bid as the **LOWEST COMPLYING** and **RESPONSIVE BID** for the said project;
