WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 20-0094 series of 2020 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL GOVERNMENT OF BOHOL in undertaking Procurement Request under PR No. 2020-0001 re: Bulk Procurement of Fuel for First Quarter of CY 2020, by the Provincial Government of Bohol, New Capitol Site, Tagbilaran City, with an ABC of ₱ 5,693,018.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BOHOL JL DISTRIBUTION SYSTEM, INC. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;
