

BAC RESOLUTION RECOMMENDING PROCUREMENT THRU SHOPPING METHOD, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD

WHEREAS, the OFFICE OF THE PROVINCIAL VETERINARIAN of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2019-0777 re: Procurement of Supply and Delivery of Cellophane, Plastic Bags & Ice Cream Cone, Office of the Provincial Veterinarian, New Capitol Site, Cogon District, Tagbilaran City. with and EPC of Php 82,237.36;


WHEREAS, canvass of prices done in the course of the Shopping Method of Procurement showed that LEZAR TRADING offered the lowest calculated and responsive quotation among the suppliers as reflected in the Abstract of Bids Quotations.


WHEREAS, pursuant to Section 52.1 of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of LEZAR TRADING including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation, LEZAR TRADING has been found to be ELIGIBLE and its quotation, RESPONSIVE:


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:


- a.) To declare LEZAR TRADING as the bidder with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** for the **DELIVERY OF GOODS/SERVICES** under Shopping Canvass No. 19-0005;
- b.) To recommend award to LEZAR TRADING for the delivery of goods/services the aforementioned request in the amount of Php 114,900.00;
- c.) To recommend that the excess amount on the quotation of LEZAR TRADING above the Estimated Project Cost (EPC) with a variance of 34.72% or Php32, 662.64 shall be shouldered by PGBh funds, considering that the said (EPC) was based from the CY 2014 approved Working Financial Plan (WFP) and Procurement Plan(PP). And the result of the pre-market survey showed that the quotation conforms to the prevailing market prices for the third quarter of 2019.
- d.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
