

**BAC RESOLUTION RECOMMENDING PROCUREMENT THRU SHOPPING METHOD, DECLARING  
LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD**

WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. PRDP-GEF-MPA-001 re: SUPPLY, FABRICATION, DELIVERY AND DEPLOYMENT OF ARTIFICIAL REEFS in a conspicuous place at the premises of the New Provincial Capitol Building, Gov. Lino I. Chatto Drive, Brgy. Cogon, Tagbilaran City, Bohol and in PhilGEPS with the EPC of Php 465,388.00;

WHEREAS, canvass of prices done in the course of the Shopping Method of Procurement showed that JR and KD Prince Enterprise offered the lowest calculated and responsive quotation among the suppliers as reflected in the Abstract of Bids Quotations.

WHEREAS, pursuant to Section 52.1 of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of JR and KD Prince Enterprise including the price quotation offered to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation, JR and KD Prince Enterprise has been found to be ELIGIBLE and its quotation RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:

- a. To declare JR and KD Prince Enterprise as the bidder with the LOWEST CALCULATED AND RESPONSIVE QUOTATION for the DELIVERY OF GOODS/SERVICES under Shopping Canvass No. 6630746;
- b. To recommend award to JR and KD Prince Enterprise for the delivery of goods/services the aforementioned request in the amount of Php 561,000.00;
- c. To recommend that the excess amount on the quotation of JR and KD Prince Enterprise which is above the Estimated Project Cost (EPC) with a variance of 20.54% of Php 465,388.00 or Php 95,612.00 shall be shouldered by the Provincial Government of Bohol funds, considering that the said unit cost for the materials was based from the CY 2014 approved Work and Financial Plan (WFP) and Procurement Plan (PP); the result of the pre-market survey showed that the quotation or bid proposal conforms to the prevailing market price for the last quarter of 2019 which justifies the amount quoted.
- d. To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
