WHEREAS, upon the conduct of post qualification by the Technical Working Group, <u>HARBEST AGRIBUSINESS CORPORATION</u> met the required legal, technical and financial requirements for the said project; Hence, for consistency purposes, the Single bid price per items shall prevail as the responsive bid price.
