WHEREAS, in the detailed evaluation of bids, **DEXTEL TRADING** for items no. **10, 12, 15 & 19**, **BYRO PHARMA** for items no. **4, 6, 8, 11 & 14** and **PHARMACEUTICA FILIPINA DE VISAYAS** for items no. **1-3, 5, 7, 9, 13 & 16-18** were declared as the Lowest Calculated Bid as Read and was recommended for post qualification;

WHEREAS, upon the conduct of post qualification by the Technical Working Group, **DEXTEL TRADING** met the required legal, technical and financial requirements for the said project;

WHEREAS, upon recommendation by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by **DEXTEL TRADING** for items no. **10, 12, 15 & 19**, **BYRO PHARMA** for items no. **4, 6, 8, 11 & 14** and **PHARMACEUTICA FILIPINA DE VISAYAS** for items no. **1-3, 5, 7, 9, 13 & 16-18** the bidders declared as the **LOWEST CALCULATED BID**, successfully passed the Post Qualification process, thus the Committee now considered its bid as the **LOWEST COMPLYING and RESPONSIVE BID** for the said project;
