WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 19-0524 series of 2020 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE PROVINCIAL AGRICULTURIST in undertaking Procurement Request under PR No. 2019-0432 re: Procurement of Pump Boat for the Conduct of Promotion & Marketing Activities for Enterprise Enhancement/Monitoring of Gate Prices of Fish & other Fishery Products, by the Office of the Provincial Agriculturist, Tagbilaran City.. with an ABC of ₱ 250,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that STEVE STEEL FABRICATION offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, STEVE STEEL FABRICATION has been found to be ELIGIBLE and its bid, RESPONSIVE;
