

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Do and Responsive Quotation and Recommending Approval

WHEREAS, the OFFICE OF THE PROVINCIAL SOCIAL WELFARE & DEVELOPMENT of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2019-0921; Procurement of Various Grocery Goods for use at the STAC-Office by the Office of the Provincial Social Welfare & Development, New Capitol Compound, Tagbilaran City. with an ABC of P75,920.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>BOHOL QUALITY</u> <u>CORP.</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>BOHOL QUALITY CORP</u>. including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>BOHOL QUALITY CORP</u>. has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare <u>BOHOL QUALITY CORP.</u> as the bidder with the <u>LOWEST CALCULATED AND RESPONSIVE BID</u> for the <u>DELIVERY OF GOODS/SERVICES</u> under Negotiated Canvass No. <u>19-0501</u>;
- b.) To recommend award to <u>BOHOL QUALITY CORP.</u> for the delivery of goods/services under Negotiated Canvass No. <u>19-0501</u> in the amount of <u>P 73,138.50;</u>
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
