

WHEREAS, the BOHOL ENVIRONMENT MANAGEMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2020-C-069 re: PROVISION OF MEALS DURING THE COASTAL & PROTECTION TRAINING with an ABC of P 107, 100.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that CASA REY FRANCIS PENSION HOUSE AND RESTAURANT offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
