WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 19-0348 series of 2019 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE PROVINCIAL VETERINARIAN in undertaking Procurement Request under PR No. 2019-0304 re: Procurement of Veterinary Equipment & Materials for Egg Hatching under BNCP (Bohol Native Chicken Program) of Office of the Provincial Veterinarian, Tagbilaran City. with an ABC of ₱ 681,000.00;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that K-9 VETERINARY SERVICES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, K-9 VETERINARY SERVICES has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:


- a). To declare K-9 VETERINARY SERVICES as the supplier with the **Lowest and Responsive Price Quotation** for the Delivery of **Goods/Services** for items no. 1 & 2 under Negotiated Canvass No. 19-0202 (2ND Failure) while items no. 3 & 4 is for cancellation;
- b). To recommend award to K-9 VETERINARY SERVICES for delivery of goods/services for items no. 1 & 2 under Negotiated Canvass No. 19-0202 (2ND Failure) in the amount of ₱ 463,000.00 while items no. 3 & 4 is for cancellation;
- c). To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
