WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 20-0198 series of 2020 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the COMMISSION ON AUDIT in undertaking Procurement Request under PR No. 2020-0021 re: Procurement of Various Office Supplies for use at Commission On Audit, Tagbilaran City. with an ABC of P 26,775.55

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PARK AVENUE GENERAL MERCHANDISE. Offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;
