



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the OFFICE OF THE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0282; re; Procurement of Engine Oil, Brake Fluid, Gear Oil, Sandpaper & Various Vehicle Spare Parts, by the Office of the Governor, New Capitol Compound, Tagbilaran City, with an ABC of P 106,655.00.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:




