

EAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

RESOLUTION NO. <u>20-01</u>93 Series of 2020

WHEREAS, the OFFICE OF THE PROVINCIAL SOCIAL WELFARE & DEVELOPMENT OF the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2019-0939 Procurement of Various Kitchenware, by the Office of the Provincial Social Welfare & Development, New Capitol Compound, Tagbilaran City. with an ABC of P 204,943.24;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>PARK AVENUE</u> <u>GENERAL MERCHANDISE</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>PARK AVENUE GENERAL MERCHANDISE</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>PARK AVENUE GENERAL MERCHANDISE</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare PARK AVENUE GENERAL MERCHANDISE as the bidder with the LOWEST CALCULATED AND RESPONSIVE BID for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. 19-0526;
- b.) To recommend award to <u>PARK AVENUE GENERAL MERCHANDISE</u> for the delivery of goods/services under Negotiated Canvass No. <u>19-0526</u> in the amount of <u>P 203,642.30</u>;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
