WHEREAS, in the detailed evaluation of bids, **SL AGRITECH CORPORATION** was declared as the Lowest Calculated and Responsive Bid for item no. 5 in the amount of **P 5,235,600.00**, **LONGPING TROPICAL RICE DEVELOPMENT, INC.** for item no. 1 in the amount of **1,498,750.00** and **SEED TO RICE PRODUCERS COOPERATIVE** for item no. 6 in the amount of **P 675,000.00** was recommended for post qualification while items no. 2, 3 and 4 is subject for rebidding; ✓

WHEREAS, upon the conduct of post qualification by the Technical Working Group, **SL AGRITECH CORPORATION, LONGPING TROPICAL RICE DEVELOPMENT, INC.** and **SEED TO RICE PRODUCERS COOPERATIVE** met the required legal, technical and financial requirements for the said project;
