

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the OFFICE OF THE PROVINCIAL SOCIAL WELFARE & DEVELOPMENT of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2019-0909 re; Procurement of Fingerprint & ID Time Attendance, 2.0 Horsepower Aircon & 1.0 Horsepower Aircon, by the Office of the Provincial Social Welfare & Development, Tagbilaran City, with an ABC of P 90,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that SAMMY'S AIRCONDITIONING & REFRIGERATION SERVICES & REPAIR SHOP offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of SAMMY'S AIRCONDITIONING & REFRIGERATION SERVICES & REPAIR SHOP including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid SAMMY'S AIRCONDITIONING & REFRIGERATION SERVICES & REPAIR SHOP has been found to be ELIGIBLE and its bid, RESPONSIVE;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare SAMMY'S AIRCONDITIONING & REFRIGERATION SERVICES & REPAIR SHOP as the bidder with the LOWEST CALCULATED AND RESPONSIVE BID for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. 19-0497 except item no. 1;
- b.) To recommend award to SAMMY'S AIRCONDITIONING & REFRIGERATION SERVICES & REPAIR SHOP for the delivery of goods/services under Negotiated Canvass No. 19-0497 in the amount of P 75,360.00 except item no. 1;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.




