



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL ECONOMIC ENTERPRISE MANAGEMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0294; re; Procurement of Electric Fan, Emergency Light, Television Set, Biometric, Sound System & Water Dispenser for use at Provincial Economic Enterprise Management Office, New Capitol Site, Tagbilaran City, with an ABC of P 97,500.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that ST. JUDE PRESS MARKETING AND SUPPLIES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.




