WHEREAS, in the detailed evaluation of bids, **COPIER SOURCE ENTERPRISES** was declared as the Lowest Calculated Bid as Read for in the amount of **P 84,990.00**;

WHEREAS, upon the conduct of post qualification by the Technical Working Group, **COPIER SOURCE ENTERPRISES** did not met the required legal, technical and financial requirements for the said project;

WHEREAS, upon recommendation by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by **COPIER SOURCE ENTERPRISES**, was failed to passed the Post Qualification process due to deficiency of the specification offered, thus the Committee now considered its bid as **NON-COMPLYING** for the said project and therefore recommended for Disqualification; **COPYLANDIA OFFICE SYSTEMS SYSTEMS CORP.** as the Second Lowest Bidder is subject for Post qualification;

WHEREAS, in the detailed evaluation of bids, **COPYLANDIA OFFICE SYSTEMS SYSTEMS CORP.** was declared as the Second Lowest Calculated Bid as Read in the amount of **P 103,999.00**.
