

**BAC Resolution Recommending Procurement thru Negotiated Method Resulting from the Second Failure of Bidding,
Declaring LCRQ and Recommending Award**

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 19-1023 series of 2020 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **PROVINCIAL ENGINEER'S OFFICE** in undertaking Procurement Request under PR No. 2019-0773 re: Procurement of Riprap Stone (Class A), Fine Aggregates (Sand), Portland Cement & Weepholes at the Provincial Engineer's Office, New Capitol Compound, Tagbilaran City. with an ABC of ₱ 2,498,669.25;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **OCcidental Enterprises** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;



- c). To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.






