



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL GENERAL SERVICES OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2019-0830; re: Procurement of Janitorial Supplies & Paper Multicopy for use at Comfort Room, Janitorial & Office Supplies at New Capitol Building, by the Provincial General Services Office, New Capitol Compound, Tagbilaran City, with an ABC of P 186,500.00.
