

WHEREAS, the **PROVINCIAL GOVERNMENT OF BOHOL** caused the advertisement and posting of Invitation to Bid in the Newspaper, PHILGEPS Website, Provincial Government Website and at three (3) conspicuous places in the premises of the Provincial Capitol Complex, Tagbilaran City of the hereunder project:

WHEREAS, in the detailed evaluation of bids, INTEGRATED SCIENTIFIC AND INDUSTRIAL SUPPLY was declared as the Single Calculated Bid as Read for items no. 1, 5, 6, 7, 8, 9, 10 & 15 in the amount of P108,910.00 and was recommended for post qualification;

WHEREAS, upon the conduct of post qualification by the Technical Working Group, INTEGRATED SCIENTIFIC AND INDUSTRIAL SUPPLY met the required legal, technical and financial requirements for the said project;

WHEREAS, upon recommendation by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by INTEGRATED SCIENTIFIC AND INDUSTRIAL SUPPLY the bidder declared as the **SINGLE CALCULATED BID**, successfully passed the Post Qualification process, thus the Committee now considered its bid as the **SINGLE CALCULATED and RESPONSIVE BID** for the said project;

NOW THEREFORE, We the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- a) To declare INTEGRATED SCIENTIFIC AND INDUSTRIAL SUPPLY as the **SINGLE CALCULATED and RESPONSIVE BID** for item no. 1, 5, 6, 7, 8, 9, 10 & 15 for the Procurement of LABORATORY SUPPLIES FOR THE USE OF THE PHO MAIN WATER SEPTAGE LABORATORY; under Project Reference No. – PHO - 2020 – 021; while items no. 2, 3, 4, 11, 12, 13, & 14 having no quotation from the supplier is recommended for rebidding;
- b) To recommend award to INTEGRATED SCIENTIFIC AND INDUSTRIAL SUPPLY in the contract amount of ONE HUNDRED EIGHT THOUSAND NINE HUNDRED TEN PESOS ONLY (P108,910.00);
