WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0286; re; Procurement of Seaweed Seedlings for the Fisheries Division at the Office of the Provincial Agriculturist, New Capitol Compound, Tagbilaran City. with an ABC of P 109,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that CARAGA FARMERS AND ENVIRONMENTAL DEVELOPERS MPC offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:




