**WHEREAS**, the **PROVINCIAL HUMAN RESOURCE MANAGEMENT & DEVELOPMENT OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. **2020-0144**; re; **Procurement of Office Supplies for use at Provincial Human Resource Management & Development Office, New Capitol Compound, Tagbilaran City**, with an ABC of **P 67,980.00**;

**WHEREAS**, canvass of prices done in the course of the Negotiated Method of Procurement showed that **PARK AVENUE GENERAL MERCHANDISE** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:




