BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the OFFICE OF THE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0280; re; Procurement of Various Spare Parts, Engine Oil & ATF Oil for the Service Vehicles Assigned under the Office of the Governor, New Capitol Compound, Tagbilaran City. with an ABC of P 108,585.00.

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>JAN SURPLUS</u> <u>CENTER</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>JAN SURPLUS CENTER</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>JAN SURPLUS CENTER</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;
