WHEREAS, the GOVERNOR'S OFFICE – BFP/ PIFARERDS of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2020-C-041 re: PROVISION OF MEALS AND SNACKS FOR THE FACILITATORS, GUESTS/ VISITORS AND PARTICIPANTS FOR THE BFP PERSONNEL AND BARANGAY BRIGADE TRAINING AND FIRE OLYMPICS 2020 with an ABC of ₱ 139, 450.00;

**NOW, THEREFORE,** We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:


