WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 19-2018 series of 2020 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the BOHOL DISTRICT JAIL in undertaking Procurement Request under PR No. 2019-0943 re: Procurement of I.T Equipment & Computer Table at the Bohol District Jail, New Capitol Compound, Tagbilaran City. with an ABC of 211,060.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that GOLDEN AI TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, GOLDEN AI TRADING has been found to be ELIGIBLE and its bid, RESPONSIVE;
